WHEREAS, the Filipino Coffee Management, Inc., is undertaking a new ende_vor to develop the Philippine Coffee Industry by creating a world-class, high-standard coffee research and development facility;

WHEREAS, the SECOND PARTY, recognizes that the government's participation and collaborative effort are critical and indispensable to and for the success of such endeavor;

WHEREAS, the SECOND PARTY has the expertise in the coffee Industry to develop facilities, training and practical assistance needed to further develop the Philippine Coffee Industry;

WHEREAS, the FIRST PARTY recognizes that there is a need to provide additional support to the SECOND PARTY in order to upgrade their institutional capability and sustain the development coffee industry that is much needed in the area;

NOW, THEREFORE, for and in consideration of the foregoing premises, the Parties have reached an Understanding as follows:

- Purpose. 

This is in response to the request for thorough review and opinion on the herewith attached draft of the Memorandum of Agreement (MOA) between the Misamis Oriental-1 Rural Electric Service Cooperative, Inc. (MORESCRO-1) and Local Government Unit of Cagayan de Oro City (LGU Cagayan de Oro City).

In this connection, kindly be informed that this Office has thoroughly reviewed the abovementioned Memorandum of Agreement and finds the same as legally sound and thus pose no legal objection to the same, save for the following observations and recommendation are respectfully specified:

1. It is recommended that the draft Memorandum of Agreement be referred to the Local Finance Committee for their review and comment as regards all the specific provisions and sections which concerns the creation of a trust fund and clarifications shall also be made on the disbursement of funds considering that the Local Finance Committee is the proper body that is vested with the technical expertise to take cognizance of the said matter relative to this Memorandum of Agreement.

Quoting hereunder the pertinent provision of the Memorandum of Agreement;

2.5. Disburse the funds from the DLF and RWMHEEF in accordance with the AWP. Such disbursements shall be subject to government accounting and post-audit by the Commission on Audit (COA).



WHEREAS, Energy Regulation ("ER") No. 1-94 Implementing Section 5 (i) of RA 7638, otherwise known as the Department of Energy Act of 1992, grant financial benefits to the host communities of the energy- generation company and/or energy resources;



MEMORANDUM OF AGREEMENT

Between Misamis Oriental-1 Rural Electric Service Cooperative, Inc. (MORESCO-1)
And Barangay Canitoan, Cagayan de Oro City

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (the "Agreement"), made and entered into by and between:

MISAMIS ORIENTAL - 1 RURAL ELECTRIC SERVICE COOPERATIVE, INC., a corporation duly organized and existing under the provision of Presidential Decree 269, represented herein by its President, NONITO LABIS, and its Acting General Manager, JOVEL B. UBAY-UBAY, (hereinafter referred to as "MORESCO-1");

- and -

Local Government Unit of Cagayan de Oro City, a Local Government Unit of the Republic of the Philippines, with office address at City Hall, Cagayan de Oro City, duly represented herein by its Municipal Mayor ROLANDO A. UY, and hereinafter referred to as "LGU Cagayan de Oro City" or the "Host Beneficiary";

MORESCO-1 and LGU Cagayan de Oro City shall hereinafter be collectively referred to as the "Parties" and individually as a "Party".

WITNESSETH: That

WHEREAS, Energy Regulations ("ER") No. 1-94 implementing Section 5(i) of Republic Act No. ("R.A.") 7638, otherwise known as the "Department of Energy Act of 1992", grant financial benefits to the host communities of the energy-generation company and/or energy resources;

WHEREAS, Section 66 of R. A. No. 9136, otherwise known as the "Electric Power Industry Reform Act of 2001" and Rule 29(A) of its Implementing Rules and Regulations ("EPIRA-IRR") require all energy generation companies and/or energy resource developers to provide financial benefits equivalent to one centavo per kilowatt-hour (PO.01/kWh) of the total electricity sales of the generation facility to the region, province, city or municipality and barangay that host the generation facility and energy resource facility, as well as the establishment of corresponding trust accounts and the administration thereof by the **Department of Energy ("DOE")**;

WHEREAS, pursuant to Rule 29(A) of the EPIRA-IRR, twenty five percent (25%) of the 0.01/kWh of the total electricity sales shall be set aside for the Development and Livelihood Fund ("DLF") and another twenty five percent (25%) of the 0.01/kWh of the total electricity sales shall be set aside for the Reforestation, Watershed Management, Health and Environment Enhancement Fund ("RWMHEEF") for use by the host region, province, city or municipality and barangay, which are required to establish the corresponding trust accounts;

WHEREAS, in accordance with Republic Act No. 8371 ("RA 8371") also known as "The Indigenous Peoples' Rights Act of 1997", the Department of Energy ("DOE") promulgated Department Circular No. DC2018-03-0005 on 20 March 2018 recognizing the rights of the Indigenous Cultural Communities ("ICCs") and Indigenous Peoples ("IPs") over their ancestral domain and the natural resources therein, including rights over a reasonable share in the DLF and RWMHEEF components of the ER 1-94 funds;

WHEREAS, on 07 August 2018, DOE issued Department Circular No. DC2018-08-0021, amending for the purpose Rule 29 (A) of the EPIRA-IRR, to accelerate socio-economic development and to have a more effective and efficient utilization of the funds and to enforce the immediate provision of benefits to Host communities;

WHEREAS, pursuant to Section 6 of DC2018-08-0021 the financial benefit shall be allocated in the following manner:

"Section 6. Allocation and Application of Financial Benefits Fund.

XXX XXX XXX

6.2. Twenty-five percent (25%) of one-centavo per kilowatt-hour (P0.0025/kWh) for Development and Livelihood Fund ("DLF"): and Twenty-five percent (25%) of one centavo per kilowatt-hour (P0.0025/kWh) for Reforestation, Watershed Management, Health and/or Environment Enhancement Fund("RWMHEEF");

The DLF and RWMHEEF shall be allocated in the following manner:

6.2.1. Community and People Affected- 5%

6.2.2. Host Barangay/s - 20%

5.2.3. Host Municipality/ies or City/ies - 35%

6.2.4. Host Province/s - 309

6.2.5. Host ICCs/IPs - 5%

6.2.6. Host Region - 5%

In the absence of Community and People Affected, funds allocated for the same shall form part of the fund for the Host Barangay.

NOW, THEREFORE, in view of the foregoing, the Parties hereby stipulate and agree as follows:

Section I. Scope of Agreement

This **Agreement** shall cover the establishment and administration of separate Trust Accounts for **DLF** and **RWMHEEF**, that shall accrue based on the electricity sales as financial benefit to the host LGUs (Financial Benefit).

Section II. Responsibilities of the Parties

1. MORESCO-1 shall:

- 1.1 Establish separate interest bearing current accounts held in trust for ER 1-94 purposes, specifically the DLF and RWMHEEF remittances to the **Host Beneficiary** ("MORESCO-1 ER 1-94 Accounts");
- 1.2 Directly remit to the **Host Beneficiary** twenty-five percent (25%) of the 0.01/kWh for DLF; and twenty-five percent (25%) of the 0.01/kWh for RWMHEEF as Financial Benefits of the host local government units in the manner set for thin Section 6 of DC2018- 08-0021;
- 1.3 Remit the Financial Benefits quarterly in accordance with the following:
- 1.3.1. For the succeeding quarterly billing periods, the remittance shall be made within fifteen (15) calendar days after the end of each billing quarter.
- 1.4 Deposit the quarterly remittance to the corresponding MORESCO-1 ER 1- 94 Accounts, in the event that the host beneficiaries fail to submit and comply with the requirements under Section 7.3 of DC 2018- 08-0021;
- **1.5** Require the **Host Beneficiary** to issue an Official Receipt ("OR") corresponding to the quarterly remittance by **MORESCO-1** of the Financial Benefits which shall include the following information:

- I. Name of LGU/Beneficiary: City of Cagayan de Oro
- II. Payor: MISAMIS ORIENTAL-1 RURAL ELECTRIC SERVICE COOPERATIVE (MORESCO-1)
 - III. Nature of Collection/Period Covered by Collection: Remittance of ER-194 Proceeds (DLF) for __Quarter 20__

IV. Total Amount (in Figures):

V Amount in Words

1.6 Subject to the post-audit to be conducted by the DOE, reflect and apply in the immediate succeeding remittance any adjustments as a result of such post-audit by the DOE.

2 The Host Beneficiary shall:

- 2.1 Establish separate trust accounts for DLF and RWMHEEF;
 - 2.1.1. If the **Host Beneficiary** has existing DLF and RWMHEEF Trust Accounts:

The Host Beneficiary shall request the Authorized Government Depository Bank (AGDB) to adopt the account names stated below and subsequently issue a certification of the said accounts, its status and current available balance.

> City of Cagayan de Oro - MORESCO-1-DLF (ER 1-94) City of Cagayan de Oro- MORESCO-1-RWMHEEF (ER 1-94)

2.1.2. If the **Host Beneficiary** does not have existing Trust Accounts:

HB shall establish trust accounts specific for DLF and RWMHEEF, under the following account names:

> City of Cagayan de Oro - MORESCO-1-DLF (ER 1-94) City of Cagayan de Oro- MORESCO-1-RWMHEEF (ER 1-94)

Within fifteen (15) days upon establishment of the trust accounts, HB shall furnish MORESCO-1 copies of documents as proof of establishment thereof.

- 2.2. Pursuant to Section 10 of DC2018-08-0021, submit to MORESCO-1 its Annual Work Program ("AWP") containing the list of tangible projects to be implemented within the reference year. The AWP shall be supported by a Resolution from its Sanggunian, certifying that said list of tangible projects is in accordance with 'its local development plans.
- 2.3. Submit to MORESCO-1 within fifteen (15) days after the end of every calendar year, the implementation status of the tangible projects contained in the AWP the utilization of the Financial Benefits in order for MORESCO-1 to verify and validate the utilization of the Financial Benefits.
- 2.4. Accept remittances of the Financial Benefits, which are deemed certified, and issue ORs corresponding to the quarterly remittances. Said remittance shall still be subject to post-audit by the DOE, and
- 2.5. Disburse the funds from the DLF and RWMHEEF in accordance with the AWP. Such disbursements shall be subject to government accounting

andpost-auditby the Commission on Audit ("COA").

Section III. Effectivity of Agreement

This Agreement shall take effect immediately upon signing by both Parties and remain valid and effective unless revoked, modified and/or amended.

Section IV. Amendments

Any amendment or modification of this Agreement will only be effective upon written consent by the Parties.

Section V. General Provisions

- 1. **Governing Law.** This Agreement shall be governed by, construed, and interpreted according to the laws of the Republic of the Philippines.
- 2. Dispute Resolution. In the event of any dispute between the Parties, the Parties shall attempt, for a period of thirty (30) days after receipt by one Party of a written notice from the other Party of the existence of a dispute, to settle such dispute in the first instance by mutual discussions. If the dispute is not settled by mutual discussions, the Parties agree to submit such dispute in the appropriate courts of Cagayan de Oro City or Misamis Oriental. During the pendency of any proceedings under this Article 6.2, the Parties (i) shall continue to perform their respective obligations under this Agreement and comply with the terms and conditions of this Agreement that are not in dispute, and (ii) neither Party shall exercise any other remedy hereunder arising by virtue of the matters in dispute. Nothing in this Article 6.2 shall prevent any Party from seeking interim injunctive or other provisional relief as may be available under applicable laws.
- 3. Non-waiver. The failure of either Party to insist on one or more instances on the strict performance of any of the covenants and conditions of this Agreement, or to exercise any right or option herein contained, shall not be construed as a waiver of said covenant, condition, right, or option. No waiver shall be deemed to have been made by a Party unless reduced in writing.
- 4. Survival. The provisions of this Agreement which are specifically stated to survive or whose operation or nature necessarily requires survival after the expiration or termination of this Agreement shall so survive such expiration or termination.
- 5. **Severability Provisions.** Should any provision of this Agreement be held invalid by any competent, court, the same shall apply only to the provision involved and the reminder hereof remains valid and enforceable.
- 6. **Sole Understanding.** This Agreement supersedes all prior agreements and contracts, both written and oral, between the Parties. The Parties specifically agree that this Agreement is the sole understanding between them concerning the terms and conditions described herein.
- 7. **Counterparts**. This Agreement may be executed in any number of counterparts, each of which shall be considered an original, but all of which, taken together, shall be considered one and the same agreement.

UY, authorized to enter this Memorandum of Agreement (MOA) pursuant to the Sangguniang Panlungsod of Cagayan De Oro City, Ordinance No.____, Series of 2024 and herein after referred to as "CDO";

WITNESSETH: That,

WHEREAS, CDO, under the present administration consider health-care and hospital services as a vital component under its RISE Agenda:

WHEREAS, CDO, thru the City Health Office, is committed to provide all relevant health program as mandated by the Department of Health (DOH), by providing health care service in the rural areas of the city;

WHEREAS, CDO promotes convergence with the different stakeholders to attain a more effective delivery of basic social services to its constituents;

WHEREAS, CDO, recognized the need to enhance and provide adequate health services to the community of Brgy. Nazareth.

WHEREAS, MRXUH, as part of its corporate social responsibility consider health services to the poor and marginalized sectors of our society as one of its flagship programs;

WHEREAS, MRXUH, has created the Arch. James T. Hayes Foundation for the purpose supporting indigent patients referred for further medical intervention from its community outreach programs/mission adopted Barangays;

WHEREAS, MRXUH, recognizes that in order to enrich the training of future Pediatricians and inculcate in them the appreciation and love of service to the poor, there is a need for their exposure to government health programs in the community setting; and

WHEREAS, the PARTIES are desirous to enter into an agreement to jointly-implement a responsive health service to the people of Brgy. Nazareth;

WHEREAS, a Memorandum of Agreement (MOA) is needed to establish the respective undertakings of the PARTIES, this city;

NOW, THEREFORE, for and in consideration of the foregoing premises, the above named PARTIES agree as follows:

ARTICLE 1 OBJECTIVE

The overall objective of the partnership is to enhance and strengthen the delivery of medical services by the **CDO** in partnership with **MRXUH**, by providing to the people of BRGY. Nazareth, easy access to the said services.

Article 2 OBLIGATION AND RESPONSIBILITIES OF THE CONCERNED PARTIES

Section 1. Obligation and Responsibilities of MRXUH:

0)

- a. Provide Pediatric Resident in the above-mentioned health facility at least 3x a week at least 2 hours a day (Monday and Tuesday) and every Thursday for health teachings;
- b. Teleconsultation services may be given in lieu of an actual attendance during the coronavirus pandemic;
- c. Facilitate referrals of patients to a higher government health facility if needed upon evaluation at Nazareth Local Health Center;
- d. Accepts referrals from the said community;
- e. Facilitate socialized support from the Archbishop Hayes Foundation and other charitable organizations those patients referred to MRXUH;
- f. Provide regular feedback to City Health Office regarding health services rendered and other health concerns of the community needing CHO attention.

Section 2. Obligation and Responsibilities of CDO:

- Allow the resident physicians of MRXUH to use the city-owned health facility at BRGY. Nazareth in providing free medical and other health services to the people in the area;
- Provide technical, logistical support and supervision thru the CHO in the said facility;
- c. Conduct regular evaluation of status of health care in the area concerned.

Section 3. No Employer-Employee Relationship. This MOA does not create an employer-employee relationship between the CDO, its officials, employees, physicians, medical staff, health workers, and its assigns and the MRXUH, its officials, employees, physicians, medical staff, health workers, trainees, assigns, and its subsidiaries and vice versa.

Section 4. Solidary Liability. In case of damage, injury or loss of life due to the negligence or intentional actions of the officials, employees, physicians, medical staff, health workers, trainees, assigns and its subsidiaries of either party, the party to whom such person is connected shall be solidarily liable thereto.

Section 5. Right to Revoke, Revise, Amend or Rescind. Either party may revoke, revise, amend or rescind the MOA by giving at least one (1) month prior notice to the other party.

Section 6. Right to Renew. This MOA is subject to review and renew every two (2) years upon its effectivity.


