ORDINANCE NO. 13968-2020

AN ORDINANCE INSTITUTIONALIZING THE CLEAN-AS-YOU-GO PRACTICE IN FOOD SERVING ESTABLISHMENTS IN CAGAYAN DE ORO CITY, PROVIDING PENALTY FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES

Whereas, it has been observed that Filipinos when dining in food serving establishments especially in fast food restaurants will just stand up and leave the tables messy and most expect that crews will clear up everything;

Whereas, as a City of Character it is the commitment of all officials and residents of Cagayan de Oro to promote and inculcate Character First virtues (descriptive virtues of a good citizen) as enumerated in Resolution No. 7676-2000, which include values of cleanliness, respect, courtesy, responsibility and trustworthiness;

Whereas, "Clean As You Go" or CLAYGO is a practice commonly observed in some fast food chains and other public places abroad to minimize risks to hygiene, health, and safety by ensuring that surfaces, tables and/or other equipment are clean, hygienic, and clutter-free. This encourages diners to make cleaning a part of their daily routine;

Whereas, more than being obsessed with cleanliness, this practice is one little way of showing care for the environment. Instead of relying entirely on street sweepers or city cleaners, we should at least make an effort on cleaning up our own mess;

Whereas, practicing CLAYGO will not only instill good citizenship, dependability and environmentalism but also teach children with good manners and right conduct;

NOW, THEREFORE:

BE IT ORDAINED by the 19th City Council (*Sangguniang Panlungsod*) in session duly assembled that:

SECTION 1. Title – This Ordinance shall be known and cited as the "Clean-As-You-Go" Ordinance of Cagayan de Oro City, or CLAYGO for brevity.

SECTION 2. Coverage – This Ordinance shall cover fast food restaurants, restaurants, carenderias, eateries, bakeries, refreshment parlors, school and office canteens, and similar food establishments or public eating places where food already cooked or drinks are served at a price.

SECTION 3. Requirement; Duties – All owners and/or managers of fastfood restaurants, carenderias, school and office canteens, and similar food establishments or public eating places are hereby required to initiate and institutionalize measures and programs within their establishments to encourage the practice of Clean-As-You-Go by their diners or customers.

For this purpose and to ensure success of this program, all owners or managers, as the case maybe, of fastfood restaurants, carenderias, school and office canteens, and similar food establishments or public eating places shall:

- (a) install signages and other promotional materials about CLAYGO within the premises of the establishment;
- (b) provide a minimum of two (2) appropriate garbage bins for plastics and other disposable utensils and for recyclables that are customer-friendly and compliant with the waste segregation regulation of the City;



(c) provide space for restaurant wares like trays, water containers, cutlery, etc.

SECTION 4. Exemption – Fine dining restaurants which provides for fancier menu, elegant/formal atmosphere and food handling services as an added premium to their customers/diners are hereby exempted from the coverage of this Ordinance.

SECTION 5. Penalty – (A) The owner/proprietor and/or manager of any establishment enumerated in Section 2 hereof which is found in violation of the provisions under Section 3 of this Ordinance shall be penalized with the following administrative fines:

(B) In the event the offender fails to pay the administrative fine hereof within seventy-two (72) hours from time of issuance of the Ordinance Violation Receipt (OVR), a complaint against such person shall immediately be filed before the courts; and if found guilty of the offenses, he/she shall be penalized with a fine of not less than ₱3,000.00 but not more than ₱5,000.00, or with imprisonment of not less than fifteen (15) days but not more than thirty (30) days, or both such fine and imprisonment at the discretion of the Court.

SECTION 6. Inclusion in the OVR System – This Ordinance shall be included in the OVR System as provided for under Ordinance No. 12139-2011 and its Implementing Rules and Regulations (IRR) per Ordinance No. 13671-2019 whose provisions shall apply suppletorily hereof.

SECTION 7. IRR – The Regulatory Compliance Board (RCB) shall prepare and draft the Implementing Rules and Regulations (IRR) of this Ordinance within sixty (60) days from the approval of this Ordinance.

SECTION 8. Information Dissemination - In coordination with the City Information Office, the RCB shall cause the dissemination of this Ordinance through the tri-media and other means.

SECTION 9. Interim – Establishments covered under this Ordinance shall be given ninety (90) days grace period, reckoned from the issuance of the IRR, within which they have to comply with the provisions hereof.

SECTION 10. Repealing Clause. All ordinances, provisions of local ordinances, executive orders, and similar issuances, which are contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 11. Severability. If any part or provision of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity and effectivity of the other parts or provisions hereof.

SECTION 12. Effectivity. – This Ordinance shall take effect after fifteen (15) days following its posting for three (3) consecutive weeks in conspicuous public places in the City and its publication in a local newspaper of general circulation.

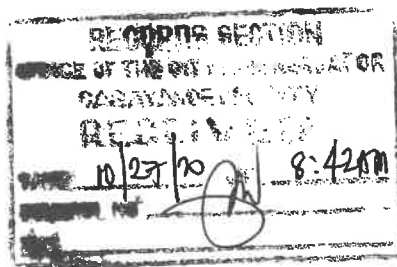

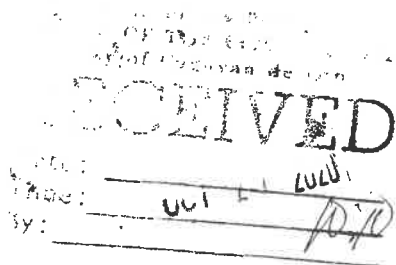

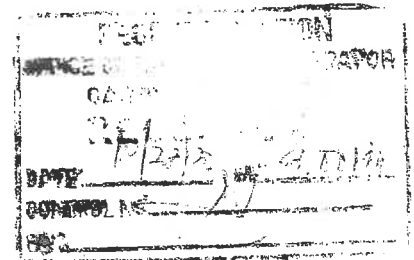
