ORDINANCE NO. 14661-2023

AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR ROLANDO A. UY, REPRESENTING THE CITY GOVERNMENT OF CAGAYAN DE ORO, TO BORROW AND CONTRACT A LOAN WITH THE LAND BANK OF THE PHILIPPINES (LBP) IN THE TOTAL AMOUNT OF ₱2,700,000,000.00, FOR THE ACQUISITION OF LAND WITH A TOTAL AREA OF 229,043 SQUARE METERS COVERED BY TCT NO. 137-201400127 LOCATED IN BARANGAY CARMEN, CAGAYAN DE ORO CITY, UNDER THE NAME OF SUSAN CID ESPAÑOLA, JOSEPH M. CID AND CHRISTINE CID TAN, AND FOR THE CONSTRUCTION OF THE NEW CITY HALL COMPLEX AND LAND DEVELOPMENT AS SPECIFIED HEREIN

BE IT ORDAINED by the 20^{th} City Council (Sangguniang Panlungsod) of Cagayan de Oro in session that:

SECTION 1. The Honorable City Mayor Rolando A. Uy, representing the City Government of Cagayan de Oro, is hereby authorized to borrow and contract a loan with the Land Bank of the Philippines (LBP) in the total amount of ₱2,700,000,000.00, for the acquisition of land with a total area of 229,043 square meters covered by TCT No. 137-201400127 located in Barangay Carmen, Cagayan de Oro City, under the name of Susan Cid Española, Joseph M. Cid and Christine Cid Tan, and for the construction of the New City Hall Complex and Land Development, to wit:
