ORDINANCE NO. 12052-2011

AN ORDINANCE ADOPTING THE PERTINENT PROVISIONS OF REPUBLIC ACT NO. 9710, OTHERWISE KNOWN AS THE MAGNA CARTA OF WOMEN, AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR) APPLICABLE TO LOCAL GOVERNMENT UNITS; AND AUTHORIZING THE CITY MAYOR TO ESTABLISH THE GENDER AND DEVELOPMENT FOCAL POINT SYSTEM (GFP) AND CREATE THE GFP EXECUTIVE COMMITTEE AND ITS TECHNICAL WORKING GROUP AS MANDATED THEREIN

BE IT ORDAINED by the City Council (*Sangguniang Panlungsod*) of the City of Cagayan de Oro in session assembled that:

SECTION 1.- The pertinent provisions of Republic Act No. 9710, otherwise known as the Magna Carta of Women, and its Implementing Rules and Regulations (IRR) applicable to local government units are hereby adopted.

SECTION 2. - For this purpose, the City Mayor is hereby authorized to establish the Gender and Development Focal Point System (GFP) and create the GFP Executive Committee and its Technical Working Group as mandated therein.

SECTION 3. - Any provision of other ordinances, rules and regulations inconsistent herewith are hereby repealed or modified accordingly.

SECTION 4. - This Ordinance shall take effect upon its approval.
