ORDINANCE NO. 14949-2024

AN ORDINANCE APPROVING THE REVISED INSTITUTIONAL DEVELOPMENT PLAN (IDP) FOR 2024-2029 OF THE CITY COLLEGE OF CAGAYAN DE ORO, AND FOR OTHER PURPOSES

Whereas, the Institutional Development Plan of the City College of Cagayan de Oro was approved on February 5, 2024 by this Council under Ordinance No. 14711-2024, entitled: *An Ordinance Approving the Institutional Development Plan (IDP) for 2024-2029 of the City College of Cagayan de Oro*;

Whereas, the Commission on Higher Education (CHED) has evaluated and assessed the said IDP and has made several recommendations thereof that are geared towards ensuring the efficient administration and operation of the City College.

Whereas, the administration of the City College has consequently incorporated the said recommendations in its IDP, which was also approved by the City College Governing Board under its Resolution No. 31, Series of 2024, and favorably indorsed to this Body by Honorable City Mayor Rolando A. Uy;

Whereas, this Body has thoroughly reviewed the said Revised IDP and found the same consistent and compliant with the guidelines, rules and regulations of CHED Memorandum Order No. 18, series of 2022, and the pertinent provisions of RA 7160, otherwise known as the Local Government Code of 1991;

NOW, THEREFORE:

BE IT ORDAINED by the 20th City Council (*Sangguniang Panlungsod*) in session duly assembled that:

SECTION 1. The Revised Institutional Development Plan (IDP) for 2024-2029 of the City College of Cagayan de Oro is hereby approved.

SECTION 2. The aforementioned Revised IDP on file with the Legislative Management Information System and Records Section of the Office of the City Secretary shall form part and parcel of this Ordinance.

SECTION 3. Ordinance No. 14711-2024, otherwise as the *City College of Cagayan de Oro Institutional Development Plan (IDP) for 2024-2029*, is hereby amended or modified accordingly.

SECTION 4. Should any provision of this Ordinance is found unconstitutional or invalid, the other parts or portions hereof not affected thereby shall continue to be in full force and effect.

SECTION 5. This Ordinance shall take effect upon its approval.
