‘SECTION 1. - The nomenclature of the position “City Government Department Head II” (Salary Grade 26 – Item # 1) in the plantilla of personnel of the J.R. Borja General Hospital is hereby changed to “Chief of Hospital III” (Salary Grade 26-Item# 1)”.
‘SECTION 1-A. – Pursuant to CSC Resolution No. 1701009, the Qualification Standards of the position Chief of Hospital III (Salary Grade 26-Item #1) shall be as follows:

- a) Doctor of Medicine with Master’s Degree in Hospital Administration or relevant field (e.g. Public Health, Business Administration);
- b) 5 years of experience in managerial or supervisory position in a healthcare facility setting;
- c) 120 hours of managerial training in the last two (2) years;
- d) RA 1080 (Physician).

‘SECTION 2. The funds necessary for the salary, RATA, PERA, GSIS/Pag-ibig/Philhealth contributions and other benefits appurtenant thereto shall be charged against the J.R. Borja General Hospital current budgetary allocation of the position “City Government Department Head II” (Salary Grade 26 – Item # 1), which is hereby deemed abolished.

‘SECTION 3. - This Ordinance shall take effect upon its approval.
