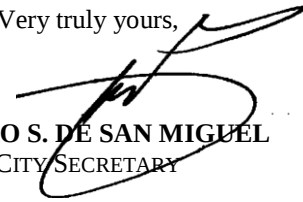

B. ON SPECIAL REPORT

- i. Councilor Reuben R. Daba proposed that the Congress of the Philippines revisit the provisions of RA 9344, otherwise known as Juvenile Justice Act of 2008, particularly the lowering of the age of persons who are not criminally liable from 15 years old to 12 years old, among other things.

Action Taken: The body adopted Resolution No. 12779-2017.

- ii. Councilor Ian Mark Q. Nacaya reported about the letter he received from Cagayan de Oro and Misamis Oriental Sports Enthusiasts, complaining that the Don Gregorio Pelaez Sports Center is being managed and operated as a private entity by the Misamis Oriental Integrated Sports Council when in fact it is owned by a tripartite government body, namely: Provincial Government of Misamis Oriental, City Government of Cagayan de Oro and the Department of Education, among other things.

Action Taken: The report and all the reactions thereof were referred to the Committee of the Whole for further investigation.

- iii. Councilor Leon D. Gan, Jr. reported and called for an investigation about the incident last Saturday wherein an enforcer of the RTA showed discourtesy to a motorist who was just asking direction where to pass, stressing that this is not the first time that some RTA enforcers showed rude and arrogant behavior.

Action Taken: The report and all the reactions thereof were referred to the Committee on Roads and Traffic Management for appropriate action.

- iv. Councilor Maria Lourdes S. Gaane reported about the outbreak of bird flu in Pampanga, which resulted to the death and culling of thousands of fowls, stressing there is a need to take precautionary measures and conduct public awareness thereof, among others.

Action Taken: The report was referred to the Committees on Health, Sanitation and Health Insurance; on Agriculture and Fisheries; and on Social Services for appropriate action.

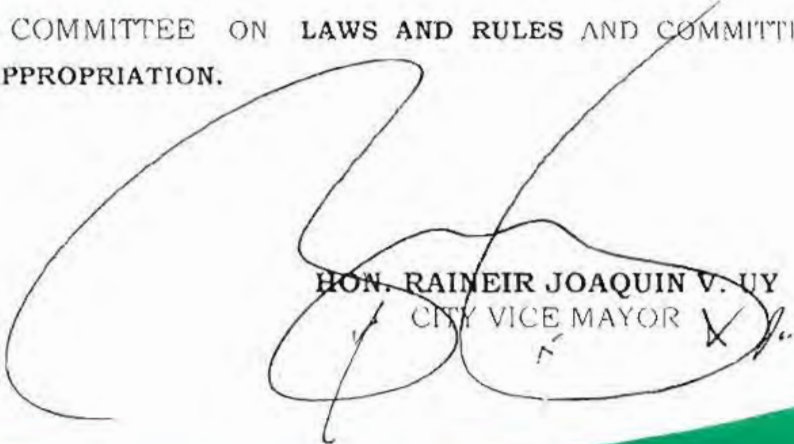

Ladies and Gentlemen:

Greetings!

This pertains to the proposed creation of three (3) ATTORNEY IV regular positions for the City Legal Office as reflected in its 2017 proposed annual budget which has already been passed upon and approved by the Hon. City Mayor Oscar S. Moreno and the Local Finance Committee, this City.

Anent thereto, kindly be informed that the creation of the afore-mentioned positions addresses the actual and urgent requirement of the City Legal Office for additional lawyers to represent the City Government of Cagayan de Oro in cases involving its interests before the regular courts of various jurisdictions and other quasi-judicial and administrative bodies. At present, the City Legal Office is currently handling 68 civil and criminal cases, more or less, all of which are actively being litigated. Needless to state, having only two (2) lawyers to handle the foregoing case load is not enough. Thus, more lawyers in the City Legal Office will not only ensure that the City Government's rights and interests in said cases are duly represented and protected, but more importantly, it will also prevent the current situation wherein the City Legal Office is put to a virtual standstill when its only two (2) lawyers are away from office attending the hearing of the aforesaid cases.

It is also important to point out that aside from court appearances, the City Legal Office also provides among others: preparation and notarial of legal documents, issue legal opinions / communications, consultations, and attend / conduct meetings. The City Legal Office is also the statutory counsel of the barangays of the city. The daily volume of notarial work and the actual time spend on research and drafting of legal opinion and communications tends to affect the efficiency and productivity of our lawyers. With the addition of new regular lawyers in the City Legal Office, we are confident that the same will improve the effectivity and productivity of the said office.

Meanwhile, in line with the City Legal Office's statutory and delegated authority to handle, investigate and hear administrative disciplinary cases against City Government personnel, the City Legal Office is currently handling numerous administrative case (46 cases at present) in which all orders, formal charges, resolutions and decisions pertinent thereto are solely endorsed to the Officer in Charge of this Office for review and approval. The foregoing is on top of the numerous endorsements for non-disciplinary personnel action for Dropping from the Rolls of City Government employees due to absence without an approved leave. The current set-up is not very ideal and more often it tends to delay the appropriate resolution of the administrative cases pending before the City Legal Office. Clearly, with the addition of new lawyers, this Office will attain its goal of ensuring the speedy and just resolution of cases pending before it.

Finally, the City Legal Office clearly needs more lawyers in order to specifically focus on the growing land acquisitions/transactions of the City Government. With the additional lawyers, the City Legal Office will be able to push through with its plan of creating a separate and distinct division which shall solely focus and handle all real property (land and improvement) transaction/acquisitions of the City Government.

It is for these reasons, in my capacity as the Officer-in-Charge of the City Legal Office, this city, that I am writing to earnestly request for the passage of an ordinance for the creation of the afore-mentioned positions taking into consideration the urgent need of this Office and in the exigencies of public service.

However, at present we could hardly obey the implementation of the writ of demolition for following reasons:

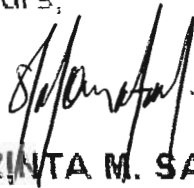
- a. The city government has no adequate relocation for the affected defendants as require under Mandatory Provision of UDHA LAW or Republic Act 7279.

Thus, we are asking for your help, if possible hold in abeyance the implementation of demolition until March 2018/ end of the school year for the reason afore-cited.

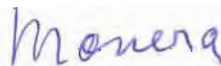
