This MEMORANDUM OF AGREEMENT entered into by and among:

The DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE 10 with principal office and business address at A. Luna St., Cagayan de Oro City represented by its *Regional Director*, LEALYN A. RAMOS, herein referred to as "DA RFO 10";

The LOCAL GOVERNMENT UNIT OF CAGAYAN DE ORO CITY with office address at Cagayan de Oro City, Misamis Oriental represented by its *City Mayor*, HON. OSCAR S. MORENO, herein referred to as "LGU".

-and-

The Paradise Village CARP Beneficiaries and Farmers Irrigators Association with office address at Cagayan de Oro City, Misamis Oriental represented by its *Chairman*, _____, herein referred to as "COOPERATOR".

WITNESSETH

WHEREAS, the DA RFO 10 supports and undertakes activities to assist and promote the development of the agriculture and fishery sector in the countryside;

5. Utilize the mechanization equipment in accordance to its intended use, allow access and use by farmers folk and shall not in any way sell or mortgage the same;

- 3) If the Land is an agriculture / pasture land planted to rice and corn, a certificate of non-tenancy from Ministry of Agrarian Reform and / or Affidavit of Waiver of Tenants.
- 4) Barangay Resolution of social acceptability.

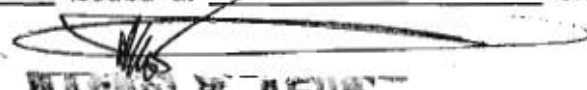
