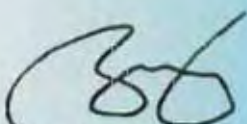

RECTO AVENUE, THIS CITY, AS INFORMATION TECHNOLOGY (IT) CENTER AND BUSINESS PROCESS OUTSOURCING BUILDING, SUBJECT TO THE FOLLOWING CONDITIONS:

- A. THIS ENDORSEMENT SHALL BE VALID FOR FIVE (5) YEARS ONLY AND THEREAFTER RENEWABLE EVERY FIVE (5) YEARS UPON REVIEW AND APPROVAL OF THE SANGGUNIAN PANLUNGSOD;
- B. SM PRIME HOLDINGS, INC. SHALL CONTINUE TO PAY REAL PROPERTY TAX (RPT) ON BUILDING OR SPACES THAT ARE LEASED OUT TO COMMERCIAL ESTABLISHMENTS WHOSE ACTIVITIES ARE NOT QUALIFIED FOR PEZA REGISTRATION. THESE COMMERCIAL ESTABLISHMENTS SHALL CONTINUE TO PAY ALL LOCAL GOVERNMENT TAXES;
- C. SM PRIME HOLDINGS, INC. INCENTIVE SHALL BE LIMITED TO THE INCOME THAT WILL BE DERIVED FROM LEASING OUT SPACES TO PEZA REGISTERED COMPANIES. THIS PARTICULAR INCOME SHALL BE SUBJECT TO THE SPECIAL 5% TAX ON GROSS INCOME IN LIEU OF ALL NATIONAL AND LOCAL TAXES AND WHICH SHALL BE REMITTED AS

FOLLOWS: 3% TO THE NATIONAL GOVERNMENT AND 2% DIRECTLY REMITTED TO THE CITY FINANCE DEPARTMENT OF CAGAYAN DE ORO;

- D. IN CASE SM PRIME HOLDINGS, INC. WILL NOT BE ABLE TO LEASE OUT ANY SPACE TO ANY REGISTERED PEZA IT/BPO COMPANY, THEN IT CANNOT AVAIL OF THIS SPECIAL 5% GROSS INCOME TAX;
- E. SM PRIME HOLDINGS INC. SHALL PAY RPT ON MACHINERY, IF APPLICABLE; AND
- F. SM PRIME HOLDINGS., INC. AND ALL ITS IT/BPO LOCATORS/LESSEES SHALL EMPLOY ABOUT 4,000 OR 80%, WHICHEVER IS HIGHER, OF THEIR TOTAL MANPOWER FROM CAGAYAN DE ORO CITY RESIDENTS IN COORDINATION WITH PUBLIC EMPLOYMENT SERVICES OFFICE (PESO).

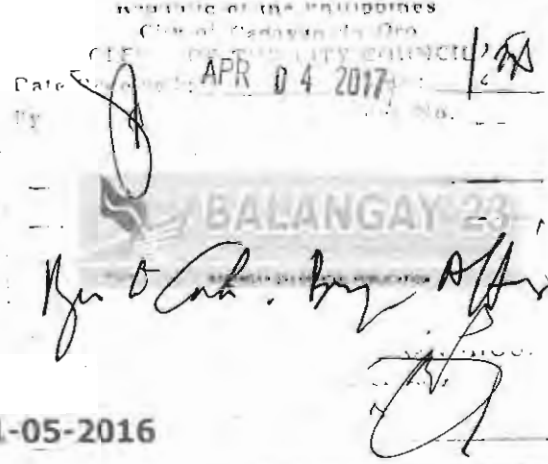

BE IT ORDAINED by the Barangay of 23(Sangguniang Barangay) of the City of Cagayan de Oro in session assembled that:

SECTION 1. Definition of terms – As used in this Ordinance, the term:

- a.) National Games refers to sports competition held within the country and participated in by athletes from various regions or cities and provinces, organized or sanctioned by national sports organizations or agencies like the DepEd, National Youth Commission, DILG and other sports organizations or associations sanctioned by the Philippine Sports Commission and/or Philippine Olympics Committee, such as the Palarong Pambansa, Batang Pinoy National Games and etc.
- b.) South-East Asian Games (SEAG) refers to the biennial games participated in by members of the Association of Southeast Asian Nations (ASEAN).
- c.) Asian Games refers to the quadrennial games participated in by Asian nations.
- d.) Olympics refers to the quadrennial gathering of athletes from all over the world and governed by the international Olympic Committee.
- e.) International or World Sports events refers to any other international or world competition sanctioned or recognized by the Philippine Sports Competition or the Philippine Olympic Committee.

SECTION 2. Amount of cash award – There shall be granted Cash Incentive Award to local athletes who have won medals or awards in national or international competition either in individual or team sports at the following rate.

SECTION 3. Appropriations – There shall be allocated a lump sum amount in the annual budget of the Barangay Sports Development Program to cover for the Cash Incentive Award granted herein. The said amount shall be disbursed of through an appropriation Ordinance enacted by the Barangay Council.

Sayre Highway (Balubal) – Manolo Fortich –Malitbog – Claveria – Eureka, Gingoog City Road);

WHEREAS, the overall objective of the Government of the Philippines is to achieve effective implementation and management of Road and Bridge projects, and the preservation of the same to sustainable operating conditions;

WHEREAS, the **Land Acquisition, Resettlement, Rehabilitation and Indigenous People Policy Framework** (to be referred hereinafter as the **Resettlement Policy**) of DPWH requires that, in the design and implementation of the project, all efforts must be exercised to ensure that:

- a) adverse social and physical impacts are avoided, minimized and/or mitigated;
- b) everybody, including project-affected families (PAFs), will benefit from the projects;
- c) PAFs are provided with sufficient compensation and assistance for lost assets which will assist them to improve or at least maintain their pre-project standard of living; and
- d) Project stakeholders (which include PAFs) are consulted regarding the project design, implementation and operation;

WHEREAS, the Operational Framework for Public Participation and Consultation of DPWH defines Participation as an active and continuous process of interaction among projects stakeholders, including the communities adversely and/or positively affected, national and local government instrumentalities, civil society and international aid agencies;

WHEREAS, the term Participation as used by DPWH encompasses information exchange (i.e., dissemination and consultation) and varying forms of decision-making (i.e., collaboration);

NOW THEREFORE, for and in consideration of the foregoing premises, the **PARTIES** do hereby mutually agree and commit themselves to the following:

1. To assist one another in ensuring that the Resettlement Action Plan (RAP) for the Project is implemented as planned.
2. To be guided by the DPWH Resettlement Policy, especially with regard to ensuring the active involvement of PAFs and other stakeholders.
3. To set up the City / Municipal Resettlement Implementation Committee (C/MRIC) in the city/municipality affected by the (a) Cagayan de Oro Diversion Road (Jct. Balubal Sayre Highway – Pueblo de Oro), CDO Airport Road), CDO – Old Airport Road Diversion Road (Pueblo de Oro /Jct. CDO – Old Airport Road) (b) Cagayan de Oro Diversion Road Ext. (Jct. Sayre Highway (Balubal) – Manolo Fortich –Malitbog – Claveria – Eureka, Gingoog City Road). With the DPWH Region X – Regional Director or his/her duly authorized representative as Chairperson and Convenor, the C/MRIC shall be composed of the following:
 - a) City Mayor or his/her duly authorized representative;
 - b) City Engineer, City Planning & Development Coordinator, City Assessor, and City Social Welfare & Development Officer;
 - c) DPWH District Engineer or his/her duly authorized representative;
 - d) Chairperson of the Barangay or his/her duly authorized representative;
 - e) Two representatives of PAFs (one male & one female) per barangay;
 - f) A representative of city/municipal-wide accredited Non-government Organization (NGO), if there is any, endorsed by the other members of the C/MRIC; and
 - g) Regional Director or his/her duly authorized representative.

The Barangay Chairperson or his/her duly authorized representative and the representative of PAFs will take active part in the activities of the C/MRIC on matters concerning their respective communities.

The C/MRIC shall have the following functions:

- a) Assist the DPWH Region X staff engaged in the RAP activities in validating the list of PAFs;
 - b) Assist the DPWH Region X staff engaged in the RAP activities in validating the assets of the PAFs that will be affected by the project;
 - c) Assist in the monitoring and implementation of RAP;
 - d) Assist the DPWH Region X staff in identifying who among the PAFs are indigenous people or belongs to an indigenous cultural community;
 - e) Assist the DPWH Region X staff engaged in the RAP activities in the public information campaign, public participation and consultation;
 - f) Assist the DPWH Region X in the payment of compensation to PAFs;
 - g) Receive complaints/grievance from PAFs and other stakeholders and act on the same within 15 days upon receipt thereof;
 - h) Maintain a complete record of all public meetings, complaints, and actions taken to address complaints and grievances; and
 - i) In coordination with concerned government authorities, assist in the enforcement of laws/ordinances regarding encroachment into the project site or Right-of-Way (ROW).
4. Once the boundaries and limits of the (a) Cagayan de Oro Diversion Road (Jct. Balubal Sayre Highway – Pueblo de Oro), CDO Airport Road), CDO – Old Airport Road Diversion Road (Pueblo de Oro /Jct. CDO – Old Airport Road) (b) Cagayan de Oro Diversion Road Ext. (Jct. Sayre Highway (Balubal) – Manolo Fortich –Malitbog – Claveria – Eureka, Gingoog City Road) is established and have been cleared of structures, the LGU shall assist DPWH to ensure and enforce the law that no new structures are constructed thereof.
 5. Transparency and collegiality will govern the relationship of the parties to this Memorandum of Understanding.

This **MEMORANDUM OF UNDERSTANDING** shall take effect immediately upon signing by the parties concerned.
