GREETINGS!

This pertains to the *Memorandum of Agreement (MOA) between the Philippine Veterans Affairs Office (PVAO) and the City Government of Cagayan de Oro, representing J.R. Borja General Hospita (JRBGH)* which was endorsed to our office during the City Council meeting held on 13 September 2018.

In this connection, kindly be informed that this Office has thoroughly reviewed the above-mentioned MOA, and the following observation and recommendation is respectfully forwarded:

1. The office would like to emphasize that it should be the City Mayor, on behalf of the City or any of its departments, that should represent the City in any agreement or understanding whereby the City undertakes to perform certain obligations¹. In line with this, the section where the parties are enumerated should instead state the following:

"The **CITY GOVERNMENT OF CAGAYAN DE ORO**, through the J.R. Borja General Hospital headed by Dr. Ramon M. Nery, with official address at J. Serina St., Cagayan de Oro City, represented herein

¹ Paragraph (vi), (1), (b), Section 455, Local Government Code of 1991,

"(vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance;"

by City Mayor, **HON. OSCAR S. MORENO**, and hereinafter referred to as the **SECOND PARTY**;"

As such, it should also be the **City Mayor's name, designation and signature**, on behalf of the City Government of Cagayan de Oro which should appear under the signatories' portion of the said agreement. Additionally, Dr. Ramon M. Nery should sign as one of the witnesses.

Also, kindly take notice that JRBGH is not a private hospital, as indicated in the section where the parties are enumerated, but a public or government hospital.

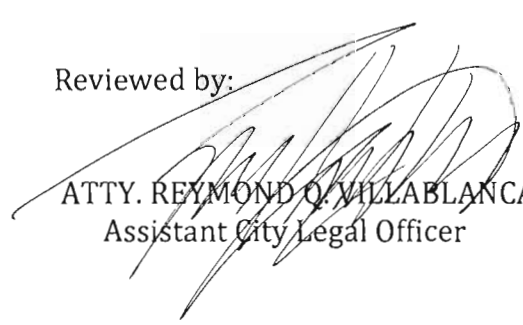

The Philippine Veterans Affairs Office (PVAO), by virtue of Republic Act No. 6948 as amended by Republic Act 7696 is mandated to provide hospitalization, medical care and treatment to Filipino veterans and their dependents through the Veterans Memorial Medical Center (VMMC) and veterans wards in selected government hospitals nationwide. To implement this program, PVAO has accredited and entered into a Memorandum of Agreement (MOA) with selected Government and Private Hospitals through the years.

We have revised the previous MOA so as to more effectively perform the objectives of the PVAO Hospitalization Program. Said revised MOA is an enhancement of the previous MOA and is expected to increase the availment of medical / health care services offered by PVAO-VMMC accredited hospitals by our veterans-clients.

We wish to inform you that, for this year, the Veterans Hospitalization Benefit increased from Php 800.00 to Php 1, 500.00 per day for 45 days per year. There are ongoing efforts to further increase this benefit by way of more funds allocation in the annual General Appropriations Act. Meanwhile, we have partnered with PhilHealth to cover all World War II veterans under its health insurance coverage in order to further enhance the program.

We wish to further inform you that, by virtue of RA 6948 as amended by RA 7696, our accredited hospitals are allowed to use reimbursements under the PVAO-VMMC Hospitalization program to support their operations.

We are pleased to inform you that the **J.R. Borja General Hospital** has been selected to be one of our accredited hospitals. As such, we are enclosing a copy of the revised and improved MOA for your signature, the signature of one of your staff members as witness, and the details of the Community Tax Certificate (CTC) or your Tax Identification Number (TIN). Kindly return the signed MOA to PVAO as soon as it is accomplished. We will then furnish you a copy of the duly notarized copy of the MOA.

WHEREAS, the **FIRST PARTY** through the Veterans Memorial Medical Center (VMMC) is a government agency mandated to provide hospitalization and medical care to veterans and their beneficiaries pursuant to Republic Act No. 6948 as amended by Republic Act No. 7696;

WHEREAS, under the said law, the **FIRST PARTY** shall accredit the **SECOND PARTY** to extend hospitalization and medical care and benefits to all veterans and their beneficiaries;

WHEREAS, the **SECOND PARTY** agrees to make available its services and facilities for authorized hospital care and treatment of veterans and their dependents in accordance with the provisions of RA 6948, as amended by Section RA 7696;

NOW THEREFORE, for and in consideration of the above premises, the parties herein agree to implement the hospitalization and medical care and treatment to the veterans and their beneficiaries as follows:

- 1.b To pay the hospitalization, medical care and treatment of veterans and their dependents confined in the accredited hospitals, based on actual billing, net of other applicable discounts, at cost but not to exceed P1,500.00 per day, up to a maximum of forty five (45) days of hospital confinement per patient per year.

The basis of payment is the Statement of Account signed by the Chief Accountant of the Hospital or Philhealth Billing Statements for Philhealth members/beneficiaries.

- 1.c To conduct actual visit/ocular inspection of the facilities of the accredited hospital
- 1.d To send the reimbursement check/s to the accredited hospital through registered mail.

2. Responsibilities of the SECOND PARTY:

- 2.a To extend hospital care and treatment to veterans and their dependents and provide all available services in accordance with generally accepted practices in all discipline/ specialties of medicine.
- 2.b To maintain standard records of treatment and services rendered to veterans and their dependents for verification purposes.
- 2.c To issue an official receipt for the payment received from VMHC.

3. Duration of the Contract

This agreement is valid for five (5) years period, unless sooner terminated by either party by giving thirty (30) days written notice to that effect.

4. Effectivity

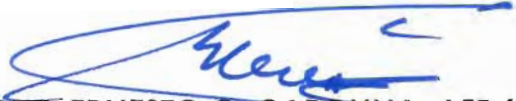
