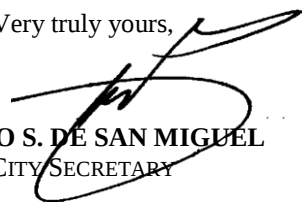

Dear Vice Mayor Uy,

In compliance with the letter sent by the Civil Service Commission Regional Office No. 10 (see attached), this is to respectfully request for change of the nomenclature City Government Department Head II (Chief of Hospital) to Chief of Hospital III, SG 26, item no. 1 of the J.R. Borja General Hospital. The latter is based on the Revised Index of Occupational Standard which we also enclosed.

Further, the CSC stressed the common mistake in the Local Government Unit on interchanging the generic position to its parenthetical position. Therefore, the LGU must be guided of the appropriate nomenclature or position titles prescribed under R.A. No. 7160 and Index of Occupational Services specially when used as parenthetical positions so that this would not entail erroneous qualification standards. It should be noted that though City Government Department Head II is the generic position for all department head positions, it does not follow that they have the same Qualification Standards.

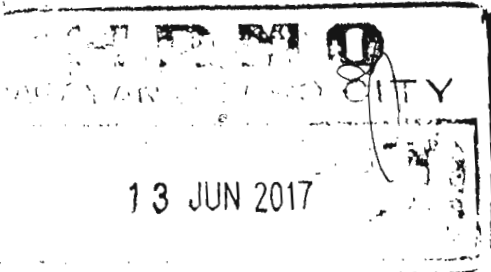
We hope that you find everything in order, and we look forward for a prompt action on this matter through a City Council ordinance.

Dear Mayor Moreno:

This is in reference to the processing of appointment in the local government units particularly mandatory and optional positions.

The Commission noted that Local Government Units (LGUs) interchangeably used the parenthetical position titles of Provincial/City/Municipal Government Department Head in lieu of department head position (i.e. Secretary to the Sanggunian, Treasurer, Assessor, Accountant, Budget Officer, Planning and Development Coordinator, Engineer, Health Officer, Civil Registrar, Administrator, Legal Officer, Agriculturist, Social Welfare and Development Officer, Environment and Natural Resource Officer, Architect, Information Officer, Cooperative Officer, Population Officer, Veterinarian, General Services Officer, etc.). It must be emphasized that said positions have different qualification standards. In view of the foregoing, and for purposes of consistency and proper implementation of the law, LGUs are advised to use the position titles prescribed under RA No. 7160 for purposes of appointment to department head positions. For instance:

Section 479, RA No. 7160 provides that:

**"ARTICLE IX
The Civil Registrar**

Section 479 Qualifications, Powers and Duties

- (a) No person shall be appointed civil registrar unless he is a citizen of the Philippines, a resident of the local government unit concerned, of good moral character, a holder of a college degree from a recognized college or university, and a first grade civil service eligible or its equivalent. He must have acquired experience in civil registry work for at least five (5) years in the case of the city civil registrar and three (3) years in the case of the municipal civil registrar.

The appointment of a civil registrar shall be mandatory for city and municipal governments."

xxx

In this regard, may we remind you of the CSC Decision No. 150684 promulgated on September 18, 2015 (MONTEGRANDE, Fiel M., Re: Invalidated Appointment (Petition for Review) (NDC - 2015 - 03009) as stated below:

"Fiel M. Montegrando, Municipal Civil Registrar, Municipal Government of Tabogon, Cebu, through counsel, files a motion for reconsideration, treated as a Petition for Review, from the Decision No. 14-0089 dated December 4, 2014 of the Civil Service Commission."

The pertinent portions of the Decision No. 14-0089 dated December 4, 2014 of the CSRO No. VII read as follows:

xxx

It is patent from the foregoing that appellant failed to meet the experience requirements in civil registry work as well in management and supervision.

Moreover, under Sec. 2 (b) Rule III of the Revised Omnibus Rules on Appointment, a temporary appointment can only be issued if the deficiency is eligibility. xxx

Apparently, appellant meets the education, training and eligibility requirements for the position except for the experience requirement. Consequently, xxx, this Office is inclined to affirm the invalidation of Montegrando's temporary appointment.

WHEREFORE, the instant appeal is hereby **DISMISSED** for lack of merit. The action of CSC Cebu North Field Office invalidating the appointment of Fiel M. Montegrando to Department Head I (Local Civil Registrar) position in the Municipality of Tabogon, Cebu, is hereby **AFFIRMED**.

In his appeal, Montegrando represents, thus:

xxx

BASIS FOR APPOINTMENT INVALIDATION WAS ON ACCOUNT OF (1) LACK OF ELIGIBILITY IN THE PRC WEBSITE AND (2) NO CERTIFICATE OF NO QUALIFIED ELIGIBLE."

xxx

Further, for positions in the administrative services group, under the DBM Budget Circular No. 2004 – 3 dated March 6, 2004 (Conversion of Positions Performing Staff/Non-Technical Functions as stipulated below:

"4.0 Definition of Administrative Service Group

4.1 Administrative Service Group includes positions which are responsible for planning, coordination, supervision and performance of functions relating to human resource xxx

5.0 Implementing Guidelines

5.1 The offices concerned of the Department of Budget and Management (DBM) shall issue Notice of Organization, Staffing and Classification Action (NOSCA) reflecting the conversion of position performing staff/non-technical function to the new classes.

5.2 The duties and responsibilities of the new position titles shall consist of the duties and responsibilities of the position titles compressed to it.

Example:

Administrative Aide II, SG 2 –operates and maintains simple reproduction machines such as photocopying machines ; collects and delivers inter-and intra - office communications.

xxx

- 5.3 Agencies shall have the flexibility to modify the duties and responsibilities of a vacant position to any of the new position titles that is needed for its operations provided it will not require additional funds.

Example:

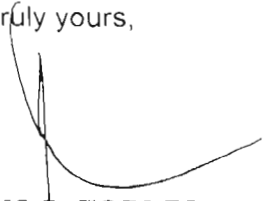
Records Officer II, SG- 14 and Cashier II SG – 14 were both compressed to Administrative Officer III, SG 14. One of the position is vacant. The agency needs a position for supply management. The agency concerned may convert the duties and responsibilities of the vacant AO III position of those pertaining to supply management and transfer the said position to the appropriate unit without need of the approval of DBM. It shall inform however the DBM of such transfer.

The above - mentioned sample showed that the compressed position which is now determined by the unit where the vacant position exist and shall be covered by the actual duties and responsibilities of the current assigned unit.

It is hoped that in the issuance of appointments, the concerned agency would see to it that all the basic qualifications required for the position is met before the submission of the appointment and Report of Appointment Issued (RAI) to CSC to ensure that no disapproval nor invalidation of appointment will happen.

We anticipate a favorable compliance in this regard..
