TO THE MEMORANDUM OF AGREEMENT (dated September 5, 2017)

This Addendum to the Memorandum of Agreement signed on September 5, 2017 (the "Addendum") is entered into this ____ day of _____, 2018 in the City of _____, Republic of the Philippines, by and between:

TEACH FOR THE PHILIPPINES, INC., a non-stock and non-profit corporation organized and existing under the laws of the Republic of the Philippines, with address at Unit 201, Asia Tower Condominium Benavidez corner Paseo de Roxas Sts., Legaspi Village, Makati City represented herein by its Chief Executive Officer, Clarissa Isabelle L. Delgado, hereinafter referred to as "TFP";

The **DEPARTMENT OF EDUCATION, DIVISION OFFICE OF CAGAYAN DE ORO CITY**, Misamis Oriental of the Republic of the Philippines with address at Father Mastersons Avenue, Upper Balulang, Cagayan de Oro, Misamis Oriental, represented herein by its Schools Division Superintendent, Dr. Jonathan S. Dela Peña, CESO VI, hereinafter referred to as "DepEd-CDO";

and

The **CITY GOVERNMENT OF CAGAYAN DE ORO CITY** of the Republic of the Philippines with address at City Hall, Capistrano Street, Cagayan de Oro, Misamis Oriental, represented herein by its Chairman and City Mayor, Honorable Oscar S. Moreno, hereinafter referred to as "LGU-CDO."

TFP, DepEd-CDO, and LGU-CDO may be referred to individually as "Party" and collectively "Parties"

Witnesseth, That

WHEREAS, the Parties entered into a Memorandum of Agreement on September 05, 2017 (the "Original Agreement", a copy of which is attached as **Appendix A**) to implement the Teach for the Philippines Program (the "Program") for the period of June 2017 to May 2018;

WHEREAS, the Parties have been adhering to their respective responsibilities as stipulated in the Original Agreement;

WHEREAS, the Parties recognize the continuing assistance needed by learners in TFP's placement schools and commit to deepening the impact of the Program for School Year ("SY") 2018- 2019;

WHEREAS, the Parties are acting in accordance with Article IV: Legal Action of the Original Agreement which states that: "Ninety (90) days before May 31, 2018, the Parties will begin the discussion and negotiation for an extension of the terms of this Agreement to SY June 2018 - May 2019 through the execution of an Addendum";

WHEREAS, LGU-CDO recognizes the need to address the funding requirement for the extension of the program until May 2019 and is willing to provide the budget for the same;

NOW, THEREFORE, in consideration of the foregoing and the mutual undertakings hereinafter set forth, the Parties hereby enter into an Addendum and retain all the provisions of the Original Agreement, insofar as the former is not inconsistent with the latter, and amend the following Sections:

1. Article I: Responsibilities of TFP, Section C: Allowance of Fellows of the Original Agreement shall be amended from "June 2017 to May 2018" to "June 2017 to May 2019"
2. Article II: Responsibilities of DepEd-CDO, Section E: Placement Period of the Original Agreement shall be amended from "one (1) school year" to "two (2) school years";
3. Article II: Responsibilities of DepEd-CDO, Section F: Monitoring & Evaluation of the Original Agreement shall be amended to extend the End-term Assessment from "2018: End-term Assessment" to "May 2019: End-term Assessment";

4. Article III: Responsibilities of LGU-CDO, Section C: Funding the Extension Classes of the Original Agreement shall be amended from "Two Million One Hundred Sixty Four Thousand Three Hundred Thirty One Pesos (Php 2,164,331.00)" to "Four Million Three Hundred Twenty Eight Thousand Six Hundred Sixty Two (Php 4,328,662.00)" (Please see Amended Budget Breakdown, a copy of which is attached as **Appendix B**);
5. Article III: Responsibilities of LGU-CDO, Section F: Placement Period of the Original Agreement shall be amended from "one (1) school year" to "two (2) school years";
6. 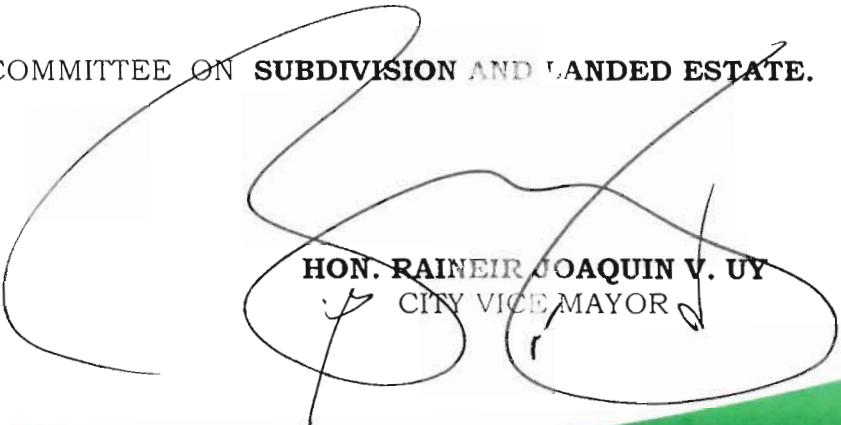

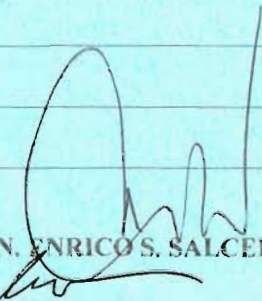

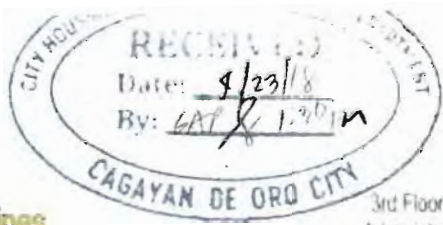
